

# RULES AND REGULATIONS OF A MASS EVENT SITE – 2024

## **I. General information**

1. The event site is managed by the University of Lodz and the Medical University of Lodz.
2. The organisation of a mass event shall take place in accordance with the Act of 20 March 2009 on mass events safety (Journal of Laws 2023, item 616).
3. The mass event site is open to all individuals at the age of majority.
4. The site is secured in accordance with safety standards to ensure the safety of event participants, as long as it is used for its intended purpose.
5. Ensuring order and safety for participants is contingent upon adherence to the Rules and Regulations outlined herein and compliance with the law.
6. During the mass event, the entire site is covered by CCTV monitoring.

## **ORGANISATIONAL AND ORDER RULES AT THE EVENT SITE**

### **II. THE RIGHT OF ENTRY to the organised event is vested in:**

1. All individuals at the age of majority.

### **III. ENTRY OF VEHICLES TO THE EVENT SITE**

Private vehicles are entirely prohibited from entering the site, except for service vehicles (marked) that are authorised to enter the site for the purpose of performing their statutory duties. Entry to the service car park shall only take place on the basis of permit issued by the organiser.

### **IV. SAFETY RULES**

1. In these Rules and Regulations, the event organiser defines the detailed rules of entry and stay at the event.
2. Participants are required to undergo security inspection upon entering the event site, as outlined in these Rules and Regulations.
3. Participants are prohibited from bringing items to the venue that may pose an immediate threat to the safety of other participants, such as firearms or gas weapons, stun guns, gas throwers, knives, clubs, chains, firecrackers, smoke candles, lasers, and other similar items which are prohibited by law.
4. Alcoholic beverages, drugs as well as glass, metal, plastic, and cardboard packaging are prohibited from being brought onto the site.
5. The use of open flames is prohibited.
6. The display of banners or boards without the organisers' permission, and the use of vulgar or insulting language that violates good morals is not allowed.
7. Bringing and wearing sports club colours, graphics, symbols, etc. is not welcomed.
8. Bringing dogs and cats or other animals into the event site is prohibited. This prohibition does not apply to guide dogs.
9. Bringing bicycles, motorbikes and other similar single and multi-track vehicles into the event site is prohibited.

10. . Individuals who fail to comply with these Rules and Regulations, or disobey the instructions given by the security and information services, may be removed from the event site.
11. All stage design and advertising elements used must be made of certified flame-retardant materials.
12. Stage design elements or advertising materials that have not been approved, or are in an inappropriate location and do not comply with fire regulations will be removed at the expense of the owner.
13. All employees working at the event site must be aware of the location of firefighting equipment and the procedures to follow in case of a fire.

**NOTE!**

14. The organiser has the right to record the course of the mass event, including the behaviour of participants, using audio and video recording equipment.
15. The organiser's security services, displaying visible badges, are responsible for ensuring security and maintaining law and order at the mass event.

**THESE SERVICES ARE ENTITLED TO:**

- a) Verify the authorisation to be present on the premises of the mass event.
  - b) Check participants' identity.
  - c) Inspect the contents of individuals' luggage or clothing in the event of suspicion that they have brought objects referred to in items IV 3 and 4 of these Rules and Regulations.
  - d) Request that individuals leave the mass event if they violate the provisions outlined in these Rules and Regulations.
  - e) Remove and immediately hand over to the Police any individuals posing a direct threat to human life, health or protected property.
  - f) Remove individuals, whose behaviour disrupts the event, from the event site.
  - g) Refuse access to the mass event to all individuals refusing to engage in activities referred to in item IV 2 of these Rules and Regulations.
16. The organiser of the mass event reserves the right to make civil law claims for compensation for any damage caused on the premises from individuals who caused or contributed to such damage.
  17. In the event of any disputes not specified in these Rules and Regulations, the provisions of the Civil Code are applicable.

The present Rules and Regulations have been drawn up in accordance with the Act of 20 March 2009 (Journal of Laws 2023, item 616).
